REPORT OF THE LEAD PASTOR

he Doors are Open!

Four years ago, our church family got inspired by God's word to a group of Jewish exiles living in the city of Babylon.

Seek the peace and prosperity of the city to which I have carried you into exile. Pray to the Lord for it, because if it prospers, you too will prosper.

Jeremiah 29:7

Although we don't live in the Middle East like those exiles, we do believe that God has placed us in a particular town at a particular time in history for a particular purpose. That purpose is to seek the well-being of Cochrane-to build friendships with and to invest in men and women, families. youth, children and seniors. For us, following Jesus isn't just about pursuing our own spiritual health. We have a heart to bless our friends and neighbours. Our prayer is that they would come to know Jesus Christ and experience the full life he offers.

This vision inspired us to take a step of faith, to make sacrifices, and to begin a journey of renovating and expanding our facility. While a building is not the point of our existence as a



congregation, its construction has catalyzed our vision to be a church that exists for the blessing of others.

Today, because of God's goodness, that vision is becoming our new reality.

By God's grace, our doors are open to the community.

In September, we welcomed over 1000 people to our Grand Opening Celebration and saw many of them join us in the ensuing weeks.

On Christmas Eve, we celebrated the birth of Christ with over 1100 of our friends and neighbours. Our facility is being used 7 days a week with businesses, community groups, and families making use of our spaces.

We are helping those experiencing loss work through the grieving process through Grief Share.

We began a new ministry called Connection Café dedicated to inviting parents to fellowship, study the Bible or learn basic life skills while their children are cared for.

In April we served as the base of operations for the most successful food drive in the history of the Helping Hands society.



Because of God's faithfulness, our ministries have grown and flourished.

Our Sunday School ministry is growing. 2017-2018 saw close to 150 children attending week-over -week with peak Sundays at over 180. And we still have space to grow!

Adults were given opportunity to grow on Sunday mornings with an Alpha Course and How to Read the Bible.

Youth ministry experienced an excellent year as students met together on Wednesday nights to have fun, learn, and worship. Beginning in February these same students were launched out of the building and challenged to begin Alpha clubs on their campuses. Over 100 students would participate at 4 different schools in the following weeks.

We initiated new programs to help people experience spiritual renewal through Set Free and Freedom Session.

Next Steps

As the Board of Elders looks ahead to 2018-2019, there are several big rocks we believe God is calling us to address.

We sense God calling us to stretch our capacity for unreserved worship during our Sunday morning services. Α survey conducted in late 2017 revealed that there is a strong desire among us for more passion, engagement, participation, and freedom of expression in our worship. We plan to address this by asking God to help us develop a culture of expectation freedom. This will mean experimenting with changes that enable us to worship with less reservation and hiring a worship pastor this coming year.

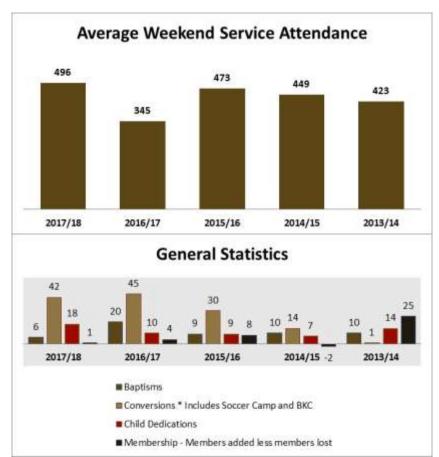
Children's ministry will continue to be a key ministry of the church

as we see many new young families settle in Cochrane. We are excited to welcome our new Children's pastor, Donna Hernandez, to lead this ministry beginning in the fall.

Our building project has left us with a sizeable mortgage that affects our ability to grow our ministry budget (see the Report of the Treasurer on page 20). The Built to Build campaign, launched this February, is designed to eliminate \$1.8 million of that debt by the end of 2019. Built to Build got off to a good start this past April with almost \$500,000 pledged towards the goal. We invite every member of our church family to consider how God is calling them to give sacrificially toward this initiative. Every dollar we save on paying interest is a dollar we could spend on building people!

As stated already, we feel strongly that the church does not exist primarily for itself, but to serve the people around it to lead them toward Jesus. Locally, we look forward to rekindling our passion for mission and outreach by developing renewed strategies to





reach out beyond our walls. Globally, our missions committee excited about new opportunities to collaborate with the Christian and Missionary Alliance to reach the Rohingya. These people have faced enormous challenges as they fled Myanmar unprecedented in numbers this past year. What an opportunity to serve them in

Jesus' name! We also anticipate seeing another floor added to the Jesus Viene School in San Raymundo, Guatemala. Watch for a fundraising initiative in late fall 2018.

Thank You!

It goes without saying that our first words of thanks must go to God. It's true: Lord, you are good,

and your mercy endures forever!

The second word of thanks goes to you, the Body of Christ, serving in the power of the Spirit. Thank you to the Board of Elders for their leadership. PASTOR OF MISSIONAL DISCIPLESHIP

missional disciple is someone who learns from Jesus: to know the Father's voice, to walk in obedience with him; and to teach others to do the same by the power of the Holy Spirit. This past year, we had several objectives for Missional Discipleship in our church, including:

- Connect our discipleship leaders to the church family.
- Emphasize pruning, abiding and healing, so that we are ready for a new season of growth, fruitfulness and mission.
- Develop easy on-ramps for individuals to engage.

Overall, I feel like the move into the new building, and Jason's sabbatical prevented me from devoting myself fully to leadership of the disciple-making work of our church. Nevertheless, that didn't prevent our church family from several Missional Discipleship "wins". Here are some of the highlights from the past year of discipleship ministry:

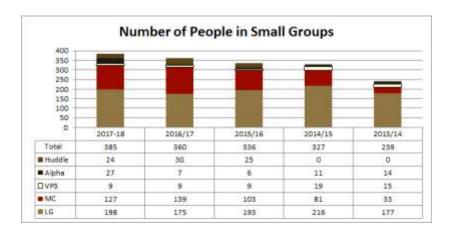
S.A.L.T. (Sisters Abiding in Light and Truth)

SALT's goal is to be arms and feet for Jesus connecting women with women through a variety of events that draw from the church as well as the community at large: Women's Retreat at FCJ Centre with 35 women attending; Movie Night "Case for Christ" with over 80 women; Christmas Craft event with approx. 25 women; Bunco game night with 29 women; a testimony night/missions night with 45-50 women; Women's Tea with over 120 people attending. It's been so exciting to see this ministry grow over the last couple of years. As more women connect, new groups and relationships are formed. As a result, we are seeing lives transforming and disciples multiplied. I grateful to Lorna Smith and the rest of the team for their leadership.

Connection Café

This is a new initiative that piggybacked on Parents & Tots. It is aimed at helping people who are available in the daytime to connect with others and take opportunities to develop in different ways. Development opportunities ranged from a Parenting Course and Life Hacks to the Alpha Course and Bible Studies. With the help of several volunteers, all these development opportunities were offered with free childcare. My thanks go out to Brenda Heavenor and the rest of the leadership team for getting this off the ground. I'm also very happy that Julia Lutchman has





come on board to keep it going this year.

Men's Discipleship

This new ministry has been a source of joy to me personally. Riding the momentum from the 4th Musketeer movement, we created a simple space for men of all ages to connect with each other and with God. Our weekly Tuesday gatherings have been a safe place for accountability and growth as disciples. The highlight for me has been the many young men like Sheldon Betts, Cam Hiebert and Joel Ulrich, who have stepped up as leaders.

Alpha Course

We took advantage of our new building in a creative way this year by offering Alpha (with brunch) during the second service on Sundays. The result was the best attended Alpha we've hosted in years. Many people experienced the gospel for the first time and were invited into a relationship with Jesus. A big thanks to the many volunteers who facilitated this effort, especially to Antoinette MacKenzie for planning a stellar brunch menu.

Looking forward, here are a few of our objectives for the coming ministry year:

People Connections

For some time, I've seen the need to bridge a gap between being a curious newcomer and being a meaningfully engaged disciple in our church family. This summer I've designed a two-week course called Discovery 101 which we will offer following each Newcomer's Café (now known as Discovery Café) this year. The

course will introduce people to our spiritual and cultural DNA and provide meaningful next steps for people to belong and to serve. All church members are also invited to "re-Discover" our church family at a Discover 101 course this year.

Discipleship Training

The success of last year's Alpha course revealed that offering accessible training concurrently with our worship services can work. To build on that, we are launching a broader array of training opportunities from Thanksgiving to Easter. I'm calling it The HUB. The vision is to equip maturing disciple-makers and launch them into the Orbit of our church to make a difference in our community.

Leadership Development

I'm on a personal quest this year to get more in tune with how I'm wired as a leader. I want to invite others to join me on this quest by creating a space called Coach's Corner four times this year. These gatherings are for anyone who is engaged in disciple-making. It will be a conversation centered on practical challenges and insights into making disciples of Jesus. Like the HUB, these gatherings will take place Sunday mornings, only during the early service.

My heartfelt thanks go out to the many people in our family who devote themselves to making missional disciples in the places that God has put them.

I am grateful we serve a God who offers hope! I am also glad that we as God's people can pass that same hope on to others who really need it!

I like to think of Cochrane Alliance Church as a lighthouse that pierces the darkness and offers safety and protection to those facing the stormy challenges of life. Our people care ministries have helped many regain their hope as they embrace a God who loves them deeply and cares about their pain and brokenness. Many people have assisted me in many ways to see this happen.

Our year of transition is behind us and now we press on to use our new expanded facility to build into the lives of many.

Front Door Ministries

We believe that a growing church is a friendly church. Each Sunday morning people are met at the door by people who care and welcome them by greeting them in a friendly way. We have a team of

40 people who are on our greeting team! Ginny Winter does a great job of organizing, communicating and training those who are greeters. She also helps to do the same with our 14 (or more) ushers who carry on the warmth as people are shown to their seats or help assist in other ways as well.

Our coffee ministry is also a small way of creating warmth and hope to those who engage in worship with us week by week. Nicqueline Shakotko has carried on the ministry of organizing our coffee people who come early each week to prepare steaming hot drinks when people arrive. Nicqueline for all of the hours you spend making our coffee ministry happen. We have 12 people who host our coffee ministry. Our new coffee machines are part of the "perks" (no pun intended) of our newly expanded building,

But our Front Door Ministry does not end at the door. We carefully trace all visitors each week and follow them up with various forms of communications. Again, Nicqueline Shakotko assists me greatly in making this happen. She also helps me plan and host our Newcomers Cafés. These informal gatherings give all

newcomers the opportunity to find out what our church has to offer. This past year we hosted three cafes with approximately 75 people attending.

A big thanks to our almost 60 people wo serve as part of our Front Door Ministry crew. Your service helps our church be a warm, welcoming place. Your ministry is important!

Pastoral Visitation Team

Pastoral care in a church our size is a shared ministry. I am grateful for those who willingly assist me in visiting those who lack mobility, those in hospitals and various care facilities as well as those who are going through life crises'. Our team is made up of the following people: Yolanda Bosma, Dave Pahl, Marianne and Daryl Bender, Pam Richardson, Dan and Winnie Williams, Harold Larsen and Bev Neufeld. Members of our Board of Elders have also assisted me with visits and prayer services for those requesting it. We estimate that approximately 80 visits were made by our Pastoral Visitation Team this past year.

Seniors (55+) Initiatives

Things were alive and moving with our Seniors this past year! Winnie Williams and committee, Doug and Arlene Dickau, Ched and Jan Evans and Dan Williams, planned and hosted eleven Senior events. Our average attendance was just over 50. Our Seniors enjoyed five potlucks, Teas (along with a hymn sing) at Christmas and in the spring, a summer BBQ as well as a Sunday lunch for Bob and Karen Thorne. Our Seniors also were involved in two outreach projects: one at Samaritan's Purse (Christmas Shoebox project) and the other at a Focus night with International Student Ministries where they prepared and served a meal to over 100 students from around the world.

The potential among Seniors in limitless. I am encouraged with the momentum we have seen this past year. Now we must build on the opportunities that are before us. Thank you, Winnie for all of the work you and your committee have done to see our Seniors group flourish again.

Grief Share Support Group

Our Grief Share ministry served 12 people who came to us to address their grief due to loss of a loved one. Catherine Legary directed this ministry in a positive, sensitive and effective way. At first, the group was a bit hesitant to share their pain and loneliness, but as each week passed they became a close family-type group as they realized the mutual benefit that came from sharing their grief.

Our Grief Share team, including Catherine Legary, Daryl Bender

and Aline Moraes. did a wonderful job facilitating this group., Thank you team for your great support! We are also grateful to Cochrane Country Funeral Home for their partnership both financially as well directing people who had suffered loss our way.

New Initiatives

This past year we had three new initiatives that were launched to meet felt needs in our church and community family.

Freedom Session was a new support group that began this past fall. It can be best described as "a healing discipleship journey that uncovers the roots of pain in our lives and invites Jesus Christ to heal those areas of our hearts" (FS Website).

We saw 28 people register for our first round of Freedom The video series Session. focused on past and present issues in people's lives and gave them a process to work through them. The requirements of the course were demanding but it was very encouraging to see people find a new freedom as a result of the 20 week course together. The final segment of the course (Authentic Living) will carry on this coming fall.

God has done great things through Freedom Session! I am so grateful to our Freedom Session team who served faithfully as facilitators and coaches this past year. This group included Robin McColl, Brenda Heavenor, John and Yolanda Bosma, Brent and Merilee Schartner, Fav VanderBaaren, and Mandie Schuler.

Together For Good was our second new initiative. It came to us through Family Life Canada with the goal to help married couples address two key themes in their marriages-differences and drift. The two presenting couples, Randy and Donna Carter and Braden and Kristen Hafner, led our 21 couples in the weekend workshop as they examined themes such as communication, conflict resolution, sexual fulfillment and spiritual oneness in an environment that was both fun and educational.

The responses from this workshop were positive in every way! This has given us a new vision for making marriage values a strong priority in our church family in the days ahead.

Why the Last Chapter of Your Life is Important Now was another workshop directed by Rick Bergh addressing important issues to those in "the last chapter of their life" (senior years). Rick is a qualified speaker on a wide range of topics such as grief, preparing for death and finishing well.

The workshop saw approximately 80 people gather to discuss the important details of starting the process of making a healthy plan for their final stage of life. Rick addressed such things as shift of purpose, the importance of considering those who are close to you and understanding suffering from God's perspective. He also addressed the five ways to get "unstuck" in the final chapter of life. The workshop was practical and well received in every way!

Chaplaincy/Care Ministries

Cochrane Alliance serves several care facilities in our neighbourhood. Dave Pahl continues to serve effectively as a part-time chaplain at Big Hill Lodge. This involves leading a worship service once a month as well as visiting Seniors in that facility. I also serve as part-time chaplain at Bethany Care Centre where I directed 12 services this past year. I also direct two services a year at Trinity Lodge in Calgary.

I have also seen a marked increase in my counselling ministry to those in our church family as well as our community. On average, I will counsel 25 people/couples a month. I am also grateful to Robin McColl and Catherine Legary who have assisted me by taking on some of the counselling load.

We are actively pursuing the possibility of groups that would deal with such things as domestic violence, divorce care, and marriage mentoring. We are consulting with FCSS to ensure that we are aware of the most pressing needs so that we can potentially address them.

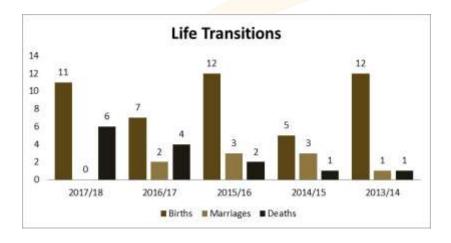

What's Been Going On

We were excited to be able to kickoff a new ministry year in our newly renovated building. After much discussion and evaluation with families we chose to move all of our programming back to the church. Our missional community groups had been meeting out of homes previously. Moving everything back to the church appears to have gone well for us as we saw an increase of 10-15% in youth participating in our ministry. Meeting at the church has allowed for our group as a whole to connect with each other more frequently and as well has allowed for our new youth worship ministry to take place easily.

Our youth missional communities (3G's) continue to be one of the main ways we do ministry. We currently have 4 missional communities that are running: two junior high and two senior high. We have about 65 youth who participate in this ministry and 16 leaders.

The other parts of our youth ministry continue to be once a month large group worship nights, once a month events to build community, Tuesday morning Bible study and 2 weekend retreats; one in fall and one in winter. As mentioned earlier we have also began a ministry to mentor

and disciple youth in music/worship ministry.

Momentum, our midweek ministry for grade 5/6 kids continues to be an important part of what we do. At Momentum, we are seeing on average 30 kids coming out on a consistent basis. Many of these kids are invited by others and are being introduced to faith for the first time. Momentum continues to provide a good and successful launching pad for sending kids into our youth ministry in grade 7. I am grateful for Jonah Barclay and Jacob McCulloch, two high school students who helped provide leadership to this group.





These young men connect so well with our preteens and are leading them in good ways!

This February we had a team of 17 from our youth ministry go and serve in Guatemala. Led by Wendy and Blaine Ellerby our team did an amazing job. Everyone on our team went expecting and asking God to show us His glory. Through the projects we were a part of, the people we served and worked with, God displayed for us His glory in many ways. Projects this year included building two bus shelters, constructing and painting benches for the school, running an outreach for the kids in the community and delivering food hampers. We were able to spend lots of time furthering existing relationships and building new ones as well. God really worked in our team in a powerful this year too. Our team shared very openly with the church and our team during times of sharing testimony and through this, God really brought our team together. Deep bonds were formed and God broke through in many lives of our team members. Upon returning home, three of our team members were baptized!

God is Moving!

We were so excited to celebrate with seven youth (grade 5-12) who chose to publicly declare their faith this year by taking the step of baptism and one who made a first time decision to follow Jesus.

This past year youth from all over Calgary and the surrounding area engaged in an initiative to see Youth Alpha run on school campuses. This all began with a desire from a group of youth pastors to see youth reaching their peers with the Gospel. After much prayer and planning it was decided to equip our youth to lead Alpha at their schools. This was the biggest highlights in our ministry this year as we saw many of our youth lead Alpha programs on their school campuses.

In Cochrane, we saw great enthusiasm and engagement from our youth to be part of this. Student led Alpha groups happened at four schools; St. Timothy, Cochrane High, Bow Valley High School and CCA/ Mitford. The leadership teams at each school included youth from Cochrane Alliance, Bow Valley Baptist and Rock Pointe. As youth pastors we were so encouraged to see our youth stepping out to lead Alpha and to have faith conversations with their peers. Each group saw about 20 people participate, and we know many seeds of faith were planted because of the obedience of youth to go and make disciples. We are trusting that God will use what has taken place to further and grow his Kingdom.

Many of you partnered with us by praying for us, our youth and the schools. We want to say thank you, as this is a big part of Alpha. Change does not happen when we fail to pray. Thank you for being a part of what God is doing through our youth in Cochrane. It really is exciting! God is on the move, and our youth are responding to His movement!

The other new initiative this year was led by Dekker Parrott, Jordan Eels, Tim Carlson and his wife Leah. Together these leaders began a worship ministry to mentor and disciple youth through music. They began meeting before youth on Wednesday nights with any student who had a

desire to be part of a worship team. Through weekly practices many youth grade 7-12 were mentored in musical development and also discipled in the area of worship ministry. This team has worked very hard with a group of about 15 youth. Starting in March this group began leading worship on youth worship nights and in May they were even able to lead worship for a Sunday service. I am encouraged to see leaders in our church using their talents and passions to come alongside our youth to disciple them.

This year our leadership grew as well and I was thankful to have our team grow in diversity when it comes to age and walks of life. God truly can use anyone to be an effective youth leader. One only needs a love for God and others. Youth are looking for acceptance, love and guidance and so many people are able to give this in our church. Our pray is that God would continue to expand our leadership team and add people

who may have never thought they would be a youth leader. Be faithful to the call and God will use you! With the help of my wife Jenna Dimnik and our friends Blaine and Wendy Ellerby our leaders continue to be discipled with ongoing monthly trainings and weekly dinners in our homes.

God is doing great things through our youth and I am so thankful to be a part of what is happening. I love seeing our youth respond to the call God is putting on their life and witnessing the change that comes from that. Thank you for your ongoing support and prayers! And consider joining our team so you can see first hand the amazing things that God is doing in and through our youth!

REPORT OF THE DIRECTOR OF CHILDREN'S MINISTRY

t was an honor and privilege to serve as your Children's Director alongside Stacey Morris as Assistant Director this past year to cover for Melanie's maternity leave. To say that it was a whirlwind is an understatement. We really appreciated how people stepped up to help and support us during this year of transition.

Late August was like an early Christmas present as we had no idea what would be in the sea cans as we unpacked. With eager anticipation we opened boxes and boxes and boxes of supplies and toys. We then had the challenge of sorting and purging and getting our rooms ready in our newly renovated facility. We are very appreciative of the huge storage space that allows us to keep our supplies organized and ready for the many volunteers who help in Sunday School.

Then came our kickoff Sunday in September where we went back to two services and everybody came back to church. We went from 80 kids at Bow Valley to 150 our first Sunday back! We needed to more than double our pool of volunteers to make it happen.

Thank you to the nearly 100 people who helped out in Sunday School. We could not have done it without you. This year we broke attendance records with 188 on Easter Sunday and averages near the 140 mark for most of the year. There are a lot of young families attending our church and that is great!

We tried a few different things this year.

Parents and Tots was expanded this year with the addition of Connection Café. Once a week we offered extra activities for parents to participate in with free child care provided by a team of amazing volunteers. There were Hacks like Bicvcle maintenance, nutrition children and more. There were craft days, a Bible study, a parenting class and more. Overall it was well received, and we plan to continue with some minor changes in the fall.

For Christmas, we did a Star Wars Christmas unit called *Star Trip -Your Faith Awakens*. The kids enjoyed learning the Christmas story in a little different format.

In January, we had a Star Wars

Knight to Remember where we invited community kids and church kids to participate in Star Wars games and we finished off with a short devotional noting parallels between the new movie and the Bible.

In February, we did a Winter Olympics unit to coincide with the Winter Games in Pyeong Chang. As an add on, we did a churchwide Lent Bible Olympics Challenge where families were challenged to read through the book of John over the 40 days of Lent. Participants celebrated with ice cream sundaes at the end.





For Easter we did *CSI Easter* where the kids investigated the empty tomb and met many eye witnesses to the resurrection. They had a chance to see if there was enough evidence to prove that the resurrection happened.

Child Dedications

This year we had another baby boom at Cochrane Alliance Church and 18 children were dedicated. We are expecting (pun intended) more babies this spring and summer so that number should continue to grow. Our vision is to walk alongside families and help them to be the spiritual leaders in their homes.

Backyard Kids Camps (BKC)

This year (2018) we focused on BKC being a stay-mission; a way to do a short-term mission trip right here in Cochrane and reach our neighbors with the good news about Jesus. It is our fifth year of partnering with Bow Valley Baptist and this partnership continues to grow and thrive. Thank you to the 182 volunteers who helped make BKC a success. We had 425 kids in 10 neighborhoods. There were 40 salvation decisions.

Soccer Camp

Again in 2018 we filled our soccer

REPORT OF THE BOARD OF ELDERS

s I reflect on the past year, I am drawn to the beginning of the book of Joshua; as God commanded Joshua to lead the Israelites out of the desert into the Promised Land - he gave him very specific instructions:

Be strong and courageous, because you will lead these people to inherit the land I swore to their ancestors to give them. Be strong and very courageous. Be careful to obey all the law my servant Moses gave you; do not turn from it to the right or to the left, that you may be successful wherever you go. Keep this Book of the Law always on your lips; meditate on it day and night, so that you may be careful to do everything written in it. Then you will be prosperous and successful. Have I not commanded you? Be strong and courageous. Do not be afraid; do not be discouraged, for the Lord your God will be with you wherever you go.

We can notice that God asked Joshua to be strong and courageous three times in order to emphasise the source and foundation of that strength and courage. First, that it was God's promise to lead His people to the promised land. Second, that it is built upon the laws God gave to

Moses and third, that God would always be with them.

We are elected and entrusted by you, the congregation to carry out many facets of oversight: spiritual well-being of the body, performance of the pastoral staff, integrity, financial ensuring adequate facilities to carry out ministry, and protecting people and property involved in these ministries. Those charged with this care and oversight of the church in 2017-2018 were: Jason Koleba, John Wicker, Jon Schwab, Blaine Ellerby, Brad Smith, Jonathan Wilcox, Dan Williams and myself.

As you can well imagine, we have had many "firsts" this year. For Jason's pastoral and administrative teams, their "firsts" were rooted in running this wonderful new building and opening its doors to both the congregation and the community of Cochrane. I can confidently report that this is going very well at all levels.

As a Board, our "firsts" were rooted in the vision of how our leadership needs to evolve with the growth and complexity of the Church. Our theme this year was "Leadership" and how we as a board need to grow in order to properly serve you and this Church.

In the fall, the Leadership Development Committee finished its work. Its mandate was to explore how the Church identifies, teaches, trains and empowers its leaders. In February, a final report was presented to the Board of Elders. I would like to thank Doyle Peterson, Mike Poettcker, Blaine Ellerby, Steve Gross, Jodi McCaw and Rini Penner for the diligent work they performed. We will use the information and insights

gathered from the committee to guide our decisions in the areas of leadership development for both staff congregational and members. We have also used the insight from this report to build better accountability in Board effectiveness. In the upcoming year, we will form a committee that will formalize a Board evaluation process that will bring better transparency and accountability to you, the members of the congregation which we serve. We are also planning a retreat where we will explore how we are to be effective witnesses of God's hope and love in today's western culture. How do we walk with strength and courage in today's culture while still being anchored in love and compassion? We also saw our Lead Pastor Jason request and was granted a welldeserved sabbatical. He used this time to rest, reconnect with his family and reflect on what God is putting on his heart as a leader, father and faithful follower of Christ.

The past year has also seen the Church host numerous activities; some traditional like our Labour Day pancake breakfast that saw over 1000 people for our grand opening and some new friends like the Rustic Charm Market, that now call Cochrane Alliance home.

We have also seen many "firsts" in the area of finances. We have been blessed by God's favour and we, as a leadership team, have been humbled at your generosity. As the financial realities settle in, we are encouraged at the continued giving heart of the congregation and the diligent hearts of our operational staff. We are also very aware that we need to be very vigilant as our mortgage has brought additional costs to our budgets and we are working very hard to decrease that debt along with the associated interest as quickly as possible. Part of that strategy is being funded by the money's committed to the "Built to Build" campaign we ran last spring.

I would like to end my report with a challenge: a challenge to be unified as a congregation in Christ. That we anchor our strength and our courage in His promises to us, in His laws and by His presence in us through the Spirit. I also challenge all of us to obediently DO what God has placed on our hearts in the areas of time, talents and treasure.

As we continue our journey into this new chapter of God's story for our Church, I leave you with the same passage I left you last year:

"Love is patient, love is kind. It does not envy, it does not boast, it is not proud. It is not rude, it is not self-seeking, it is not easily angered, it keeps no records of wrongs." (1Cor13:4)...

"And now these three remain: faith, hope and love. But the greatest of these is love." (1Cor13:13).

Let us embody the true nature of our creator - God is Love who gives us strength and courage.

What an amazing year we've just come through! In the summer of 2016, we moved out of our old building and worshiped together at Bow Valley for just over a year. In September 2017, it was so wonderful to walk into our beautiful newly renovated facility for our first Sunday of worship! All this was made possible by the fervent prayer and sacrificial giving of so many of you.

When I think about those who give at Cochrane Alliance, I'm reminded of the widow Jesus tells us about in Mark 12. Her sacrificial giving mirrors the sacrificial giving that many of you make toward the work of Jesus that we are doing here. I've said it before and I'll say it again; thank you to each of you that give to Cochrane Alliance!

"But a poor widow came and put in two very small copper coins, worth only a few cents. Calling his disciples to Him, Jesus said, Truly I tell you, this poor widow has put more into the treasury than all the others." Mark 12:42,43 Our General Fund revenue this year was \$854,781 (\$14,596 of budget), short whereas expenses were \$874,919 (\$5,542 over budget), resulting in a General Fund shortfall of \$20,138. We are thankful to the Lord for another year of strong giving and faithful givers, despite our year of "being in the wilderness" at Bow Valley Baptist. Our giving to the Global Advance Fund as of the end of the fiscal year was \$56,019.

The final amount of our loan through the District is \$2,860,000 for the renovations. As of June 30, 2018, we are down to \$2,694,569 - a repayment of \$165,431 in that short period of time. Our current payment agreement with the District means we are making \$25,000 towards principal and \$9,000 towards interest, for a total of \$34,000 per month towards the mortgage.

After the successful Open the Door campaign, we have now moved into phase 2, called Built to Build. As of June 30, 2018, we have raised \$410,104! Thank you

again for your giving to retire this debt. Please prayerfully continue to support the Built to Build program.

The major challenge for Cochrane Alliance Staff and Finance Committee this past fiscal year, and now into the new year, has and will be the adjustment to our "new" normal in our renovated building. Things like multiple HVAC units, new insurance premiums, and increase of utilities have all put a strain on our current budgetary numbers. As we move into the 2018/2019 fiscal year, these new budget numbers reflect more accurately what we will be looking at.

In 2018/2019, our task is to balance the new building, retire the mortgage, and continue ministry plans through these continuing tougher economic times. Our overall operating budget (General Fund operating expenses, plus other operating expenses) for the coming fiscal year is \$1,025,016.

I would like to give a sincere thank you to the members of the Finance Committee. These folks really are the brains of the operation: Brenda Heavenor, Daniel Souza, and Mike Poettcker. They put in that extra time to ensure numbers are accurate, up to date, and fiscally responsible.

As Cochrane Alliance Church moves into our next budget year, I ask that you would pray daily for our staff and finance committee, our finances and how you can contribute financially. In keeping with our church's vision of Kingdom Extension locally and globally, we need you to come alongside and partner with us!

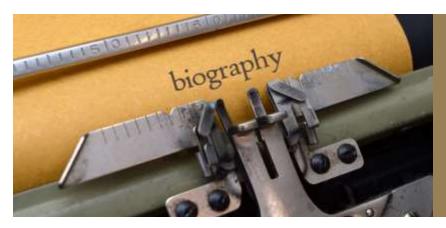

Practical Procedures for Annual General Meeting

The very words "parliamentary procedure" strike terror into the hearts of most men and women. And rightly so!

Parliamentary procedure, when carried to extreme, can be a bore. It can be a nuisance, and a real pain. However, a little understanding of basic, practical parliamentary rules and procedures will avoid wasting time and ensure that business is accomplished.

So this material is put together with the idea of providing every member with a minimum of details on correct business procedures. Correctly used, an understanding of parliamentary procedure will inform you in the efficient and smooth operation of a meeting ensuring that the majority rules, but that the minority is given a chance to speak.

AGENDA

Please ensure that you have adequately prepared for the business meeting by reading the Annual Report carefully and noting any questions for clarification. It is also considerate to submit well in advance any new items for discussion at the annual meeting to the Board Chairman. This greatly assists the chairman in preparing for the discussion.

There will be no formal reading of reports contained in the distributed Annual Report. It is expected that all reports have been read prior to the general meeting and, therefore, only questions pertinent to the report will be entertained.

Adjournment will be scheduled and publicized at a pre-determined time. It may only be extended by a majority vote on behalf of the membership, and then only for a maximum of one half hour.

MOTIONS

The Main Motion

This is the most common motion used at any business meeting. A "motion" is the method used to introduce a new subject for discussion at the business session. While it is called the "main motion", it is of the lowest rank or priority. Therefore, a "main motion" can be introduced *only when there is no other business before the meeting*.

Without making a motion sound complicated, it is important to know (and understand) the eight individual steps in the proper presentation of *any* motion:

A member rises and addresses the chair.

The chair recognizes the member.

The member states his/her motion ("I move that ...")

Another member seconds the motion (without rising or addressing the chair).

THE CHAIR STATES THE MOTION (ensuring all members know wording).

Members discuss the merits of motion. (Each member receives recognition from the chair first. See item #1 and #2

Members vote on motion. (Chair says, "Those in favor, say Aye", etc.)

THE CHAIR ANNOUNCES THE RESULTS OF THE VOTE.

The Amendment

Although amendments seem designed solely to challenge the ability of the chairman and confuse the membership, that isn't

An amendment is designed to change or modify a main motion that has already been introduced to the meeting and is currently under discussion by the membership. An amendment may be introduced at any time during the discussion period.

An amendment is introduced by a member when he/she is basically in agreement with the main motion, but feels that a slight change or alteration to the wording of the main motion might make it even better.

Therefore, all amendments should indicate clearly what changes the member wants to make to the wording of the main motion.

Possible wordings can be divided into four sets:

I move that we amend the motion by adding the words . . .

I move that we amend the motion by striking out (deleting) the words ...

I move that we amend the motion by inserting the words \dots

I move that we amend the motion by **striking out** the words ... and **inserting** the words ...

If another change is required, simply vote first on the amendment that has been proposed - either accepting or rejecting it - then go ahead and propose another amendment to the main motion if desired. It is important to know that you must vote on the amendment first, then you must vote on the main motion (main motion as amended).

REVIEW ENGAGEMENT REPORT

To the Members of Cochrane Alliance Church of the Christian and Missionary Alliance

We have reviewed the statement of financial position of Cochrane Alliance Church of the Christian and Missionary Alliance as at June 30, 2018 and the statements of revenues and expenditures, changes in net assets and cash flows for the year then ended, and a summary of significant accounting policies and other explanatory information.

Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Canadian accounting standards for not-for-profit organizations, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

Practitioner's Responsibility

Our responsibility is to express a conclusion on the accompanying financial statements based on our review. We conducted our review in accordance with Canadian generally accepted standards for review engagements, which require us to comply with relevant ethical requirements.

A review of financial statements in accordance with Canadian generally accepted standards for review engagements is a limited assurance engagement. The practitioner performs procedures, primarily consisting of making inquiries of management and others within the entity, as appropriate, and applying analytical procedures, and evaluates the evidence obtained.

The procedures performed in a review are substantially less in extent than, and vary in nature from, those performed in an audit conducted in accordance with Canadian generally accepted auditing standards. Accordingly, we do not express an audit opinion on these financial statements.

Conclusion

Based on our review, nothing has come to our attention that causes us to believe that these financial statements do not present fairly, in all material respects, the financial position of Cochrane Alliance Church of the Christian and Missionary Alliance as at June 30, 2018, and the results of its operations and its cash flows for the year then ended in accordance with the Canadian accounting standards for not-for-profit organizations.

1. NATURE OF OPERATIONS

Cochrane Alliance Church ("CAC") is a congregation located in Cochrane, Alberta. The congregation desires to be a church transformed by Christ, multiplying Christ-centred homes, renewed lives and missional disciples in Cochrane, Canada and the world.

CAC is an unincorporated church which is a member of the Christian and Missionary Alliance in Canada, and is included in the Western District of the Christian and Missionary Alliance in Canada ("District"). CAC is exempt from income tax because it qualifies as a charitable organization, and is registered to issue charitable donation receipts for income tax purposes.

The continued operation of CAC is dependent on the ongoing donation support of those interested.

2. ACCOUNTING POLICIES

Basis of presentation

The financial statements were prepared in accordance with Canadian accounting standards for not-for-profit organizations (ASNFPO).

Going Concern

The preparation of financial statements in accordance with Canadian Accounting Standards for Notfor-Profit Organizations requires management to assess whether there are any events or conditions that may cast significant doubt upon the Church's ability to continue as a going concern. An entity is a going concern when it is able to convert its assets to cash and discharge its liabilities in the normal course of operations. Management is not aware of any such material uncertainties; accordingly these financial statements have been prepared using the going concern assumption.

The Church follows policies in line with the Canadian Accounting Standards for Not-for-Profit Organizations in the preparation of its financial statements, a summary of which are as follows:

Fund accounting

Cochrane Alliance Church of the Christian and Missionary Alliance follows the restricted fund method of accounting for contributions.

The Capital Fund receives contributions and reports activities for maintaining and renovating property, and retiring debt, if any.

The **Missions Fund** receives contributions and reports activities for missions projects undertaken by the Church, and provides support for domestic and foreign missions.

The Other Restricted Fund receives contributions and reports activities for benevolence, pastoral housing loans, local missions, and community outreach projects approved by the Elders.

The General Fund receives unrestricted contributions and accounts for the Church's program delivery and administrative activities.

Financial instruments

Financial instruments reported in these financial statements include cash and cash equivalents, other receivables, staff loans, and accounts payable.

Financial instruments are recorded at fair value when acquired or issued. In subsequent periods, financial assets with actively traded markets are reported at fair value, with any unrealized gains and losses reported in income. All other financial instruments are reported at amortized cost, and tested for impairment at each reporting date. Transaction costs on the acquisition, sale, or issue of financial instruments are expensed when incurred.

The Church is exposed to various risks through its financial instruments and has a comprehensive risk management framework to monitor, evaluate and manage these risks. The following analysis provides information about the Church's risk exposure and concentration:

Liquidity risk - this is the risk that an entity will encounter difficulty in meeting its obligations associated with financial liabilities. The Church is exposed to this risk because of uncertainty in the amount and timing of contributions expected to be received from its members and adherents.

Unless otherwise noted, it is management's opinion that CAC is not exposed to significant interest, currency or credit risks arising from these financial instruments.

Cash and cash equivalents

Cash and cash equivalents consist of cash in banks, balances outstanding on the line of credit, and investments, if any, convertible to cash within 90 days. The carrying amounts approximate fair value because of the short term to maturity.

Property and equipment

Property and equipment are recorded at cost on acquisition. Property under construction is not amortized until placed in use. Contributed capital assets are recorded at fair value on the date of contribution. Property and equipment are amortized over their estimated useful lives at the following rates and methods:

Land improvements	5%	straight-line method
Buildings and improvements	2.5%	straight-line method
Computer equipment	20%	straight-line method
Furniture and fixtures	10% - 33%	straight-line method

The Church regularly reviews its property and equipment to eliminate obsolete items.

Revenue Recognition

The Church follows the restricted fund method of accounting for contributions. Revenue from contributions is recognized when received.

- a) Contributions restricted by donors for projects approved by the Elders Board are accounted for as restricted and spent according to their designation.
- b) Contributions related to general operations are recognized as revenue of the General Fund and are spent at the direction of the Elders Board.
- c) Contributions of gifts in kind are recorded at their fair market value, which is the amount for which a donation receipt is issued.

Contributed Services

During the year, volunteers are required to assist CAC in operating its programs. Because of the difficulty of determining the number of hours provided and their fair value, contributed services are not recognized in these financial statements.

Allocated expenses

CAC reports expenses on a functional basis in the statement of operations, including Ministries, Missions, Facilities, and General and Office. Expenses which are directly related to a particular function are charged to that function. Expenses not directly related to a specific function are included in General and Office expenses, and are not otherwise allocated to other functional areas.

4. STAFF LOANS

In 2014 the Elders approved the creation of an internally restricted pastoral housing fund for the purpose of extending interest-free loans to new staff members wanting to buy a house upon moving to Cochrane. The loans are for a maximum of \$15,000 per staff person, repayable over a period of 10 years in equal monthly payments. One loan for \$15,000 was provided during 2015.

Consistent with the requirements of the Constitution of the District, title to the land and building bought and paid for by CAC is registered in the name of the District. While ownership of these assets rests with the District, their cost and related accumulated amortization have been recorded in these financial statements rather than the financial statements of the District, as CAC uses these assets in its operations and is responsible for their management and maintenance. This treatment is consistent with that adopted by the District and substantially all of the other congregations who are members of the District.

Management of CAC is of the opinion that this requirement does not preclude the recording of the land and building as assets of CAC, as CAC has exclusive use of the land and building for worship services and other activities.

The District has provided the land and building as collateral to secure advances outstanding from time to time, if any, on the Royal Bank Master Lending Agreement.

BANK LINE OF CREDIT

The Church has negotiated an operating line of credit with the Royal Bank. The line of credit is for a maximum of \$50,000 and bears interest at prime + .5%. As the line of credit has been negotiated under the Master Lending Agreement between the District and the Royal Bank, the Western Canadian District has guaranteed the repayment of any unpaid amounts. No advances had been received during the year and there was no balance owing at June 30, 2018.

In 2015, CAC was approved by the District to undertake a renovation and expansion project on the church site, originally budgeted not to exceed \$4,200,000. With anticipated pledges of \$2,700,000, WCD agreed to provide financing of \$1,500,000 plus interim financing as required until the capital campaign is completed. The terms during the construction phase were for monthly payments of interest only, based on bank prime rate + .5%. As title to the church property rests with the District (Note 5), the property is collateral for the financing provided.

As construction was completed in September 2017, CAC used a portion of funds received under the Open the Door campaign to pay down principal by \$165,431.

Interest of \$96,071 (2017: \$6,944), calculated at rates varying between 3.2% and 4.2% during the year, has been included in the statement of operations for the Capital fund.

8. TRANSACTIONS WITH THE DENOMINATION

CAC is a member of the Western Canadian District of the Christian and Missionary Alliance. As a member, CAC works with both the District and the national organization of the Christian and Missionary Alliance, providing support funding to accomplish mutual objectives, including missions efforts in Canada and abroad. However, CAC is not related to the District or the national organization, as each has its own independent Board managing their own affairs.

The following is a summary of the Church's transactions with the District. These transactions are in the normal course of operations and are measured at the amount of cash transferred.

9. CAPITAL FUND-RAISING CAMPAIGN

During 2015-2017, CAC conducted a three year Open the Door fund-raising campaign to facilitate the renovation and expansion of the present church site. The expansion has cost approximately \$4,800,000 which has been financed through receipt of pledges of approximately \$2,100,000 and a mortgage from the Western Canadian District of the Christian and Missionary Alliance of approximately \$2,700,000 with interest at bank prime +.5%.

Following completion of the renovation in September 2017, CAC commenced the Built to Built fundraising campaign with an objective of raising \$1,700,000 by the end of 2019. Funds raised are intended to be applied to reduce the \$2,700,000 mortgage provided by the Western Canadian District of the Christian and Missionary Alliance to approximately \$1,000,000. Pledges of approximately \$475,000 have been received under this campaign, of which CAC has received approximately \$82,000 at June 30, 2018.

10. PENSION COSTS

Certain employees of the church are members of a defined contribution pension plan operated by the denomination. During the year ended June 30, 2018 CAC contributed \$18,736 (June 30, 2017 - \$20,687) to the plan, as included in total staff remuneration and benefits expense. As the plan is a defined contribution plan there is no potential for a contingent liability arising from underfunded contributions.

The Bylaws of Cochrane Alliance Church

COCHRANE ALLIANCE CHURCH

BYLAWS

Preamble

Cochrane Alliance Church (as hereinafter defined), an unincorporated association, is a member of The Christian and Missionary Alliance in Canada (hereinafter the "C&MA"), and is governed by the "Local Church Constitution", as amended from time to time, which has been adopted by the general assembly of the C&MA (hereinafter the "Local Church Constitution").

Cochrane Alliance Church may, in accordance with the provisions of the Local Church Constitution, adopt additional bylaws, provided that such additional bylaws do not conflict with the Local Church Constitution.

The policies and regulations of Cochrane Alliance Church shall be consistent with, and Cochrane Alliance Church shall operate in accordance with, the Manual of the Christian and Missionary Alliance in Canada as amended from time to time.

ARTICLE 1 - NAME

This church shall bear the corporate name of the Cochrane Alliance Church of the Christian and Missionary Alliance in Canada hereinafter the "Cochrane Alliance Church"

ARTICLE II - MEMBERSHIP

- 1. Active members of the church will be those members who have been approved for membership by the Board of Elders, attend regularly, participate in the activities of the church and promote the vision of the church. Active members will be asked to affirm their membership commitment annually. If a written response to the Board of Elders request for affirmation is not received, the Board will meet with the Active Member to determine their status.
- 2. Members who do not meet the standard of Active Membership shall be considered Inactive Members, and shall have no voting privileges until reinstatement. If inactive for twelve months, Inactive Members will be advised by written notice and removed from the membership list.
- 3. Active Members who are unable to participate in the work of the church due to involvement in Christian ministries in another locale, may apply for Associate Membership, but shall not have voting privileges.
- 4. If, at any time, the Board of Elders deems that a member does not meet the qualifications for membership, they may, upon careful examination and exhortation of the person, withdraw the person's membership by a three-fourths majority vote.

ARTICLE III - GOVERNMENT

- 1. The Board of Elders is responsible for setting a date for the Annual General Meeting (AGM) to be held within the first four months of the fiscal year.
- 2. Notice of all congregational meetings shall be given from the pulpit and shall be printed in the Sunday

bulletin on at least two consecutive Sundays prior to the congregational meeting.

- 3. Special congregational meetings may be called by the Board of Elders. Notice of such meetings will be in accordance with Section 2 of this Article and shall advise the congregation as to the purpose of the special meeting.
- 4. Ten percent or more of the membership may request in writing of the Board of Elders that a special congregational meeting be called and held. Such a meeting will then be called in accordance with Section 3 of this Article.
- 5. A quorum of any duly called meeting consists of the membership present.
- 6. All questions of parliamentary procedure not covered by the constitution and bylaws shall be decided by Robert's Rules of Order.

ARTICLE IV - BOARD OF ELDERS

- 1. The Board of Elders shall consist of the Lead Pastor and a minimum of three elected elders. Additional elder(s) may be elected as the church congregation grows in number.
- 2. Elders shall be elected to a term not exceeding three years. A three year term is defined as beginning at the AGM when the elder is elected and ending at the AGM three years hence. An elder can serve on the board for a maximum of two consecutive terms after which they must step off the board for a minimum of one year.
- 3. A quorum of the Board of Elders shall consist of a simple majority of its members.
- 4. When the church is without a lead pastor, the elders will have oversight of the services of the church.

ARTICLE V - PROPERTY AND RECORDS

- 1. An independent professional accounting firm shall be appointed by the Board of Elders before the end of each fiscal year. It shall be the duty of the accounting firm to submit a written report to the annual meeting with regards to property and records for which a review engagement or audit has been conducted.
- 2. A member wishing to inspect the official records may make such a request in writing to the secretary of the Board of Elders. The request must specify the item the individual wishes to review.
- 3. The fiscal year shall be from July 1 to June 30.
- 4. The spending of funds is confined to board-approved programs and projects. Each restricted contribution designated towards a board-approved fund, program, or project will be used as designated with the understanding that when the need for such a fund, program, or project has been met, or cannot be completed for any reason determined by the Board of Elders, the remaining restricted contributions designated for such fund, program or project will be used where needed most.
- 5. Cochrane Alliance Church shall, in accordance with the provisions of the Local Church Constitution, register all real property in the name of The Western Canadian District of the Christian and Missionary Alliance in Canada, and should Cochrane Alliance Church cease to exist or cease operations, then:
- (a) all of its real property, appurtenances and effects then owned or held by it shall inure to the benefit of and become the property of The Western Canadian District of the Christian and Missionary Alliance in Canada; and
- (b) all of its other property and assets shall be distributed to one or more qualified donees."

ARTICLE VI - NOMINATING COMMITTEE

The Nominating Committee shall consist of the Lead Pastor and two members from the Board of Elders, as well as two members elected by and from the congregation.

ARTICLE VII - BYLAW AMENDMENTS

- 1. The Bylaws may be amended from time to time following a two-thirds majority vote of the members present at an annual meeting or a special membership meeting called for such purpose.
- 2. The active members present constitute a quorum in order to amend the bylaws.
- 3. Proposed amendments to the Bylaws shall be posted for the membership at least two Sundays prior to the date of the membership meeting called to consider approval of the same.

ARTICLE VIII - REVOCATION

All Cochrane Alliance Church versions of the bylaws which have changed or been deleted at this meeting are hereby revoked.
